**O R D E R**

**WHEREAS New Brunswick Power Distribution and Customer Service Corporation (“Applicant”) has applied to the Board of Commissioners of Public Utilities (“Board”) by an Application dated March 21, 2005, for approval of changes in its charges, rates and tolls;**

**NOW THEREFORE IT IS ORDERED THAT:**

- (a) A Pre-Hearing conference shall be held at the Delta Brunswick Hotel, Saint John, New Brunswick on Tuesday, the 17<sup>th</sup> day of May, 2005 commencing at 10:00 o’clock in the forenoon, and from day-to-day thereafter as required, when and where the Applicant and Intervenors should attend and make representations as to the date of the full public hearing to review the changes for which approval has been applied and the procedure to be followed prior to and at the full public hearing and any other matters in respect thereto.
